## OFFICE MEMORANDUM

Subject: Relaxation for pre-shipment fumigation with Methyl Bromide (MBr) from countries, which have phased out use of MBr - reg.

All the Officer In-charges of RPQSs/PQSs may refer to Directorate's Office Memorandum No. 99-74/2018-PQD dated 20<sup>th</sup> May, 2019 and Office Memorandum of even number dated 17<sup>th</sup> May, 2023 regarding relaxation for pre-shipment fumigation with Methyl Bromide (MBr) from countries, which have phased out the use of MBr. In this regard, it is informed that as per Directorate's O.M issued on 20<sup>th</sup> May, 2019, there were many countries listed (*Annexure I*) under MBr phased out countries, however, less number of countries listed (*Annexure II*) under MBr phased out countries as per Directorate's O.M issued on 17.05.2023, since, many countries have not submitted the relevant documents to NPPO, India to establish phased out country status in accordance with the Gazette notification No. S.O. 4871(E) dated 13<sup>th</sup> October, 2022. Hence, the Competent Authority in Department of Agriculture & Farmer's Welfare has directed to allow the release of consignments as per the earlier list of MBr phased out countries specified in *Annexure I* on the following conditions for which fumigation treatment is stipulated in Plant Quarantine (Regulations for import into India) Order, 2003:

- The import of agricultural commodities covered under the Bill of Lading (BL) issued by the country of export dated 17<sup>th</sup> May, 2023 or before, will be subjected to conditions specified in Directorate's Office Memorandum No. 99-74/2018-PQD dated 20<sup>th</sup> May, 2019.
- ii. The import of agricultural commodities covered under the Bill of Lading issued by the country of export after 17<sup>th</sup> May, 2023, will be subjected to conditions specified in Directorate's Office Memorandum of No.102-1/2017-PQD dated 17<sup>th</sup> May, 2023.
- iii. The present order will not affect the relaxations given in respect of pulses vide Office memorandum No. 18-9/2021-PP. II(e-104300) dated 05.03.22.

### **OFFICE MEMORANDUM**

Subject: Relaxation for pre-shipment fumigation with Methyl Bromide (MBr) from countries, which have phased out the use of MBr - reg.

All the Officer-In-Charges of RPQSs and PQSs may refer to DA&FW Gazette Notification issued vide S.O. 4871(E) dated 13.10.2022 (https://egazette.nic.in/WriteReadData/2022/239640.pdf), wherein, amendment in chapter II, Clause V of Plant Quarantine (Regulation of Import into India) Order, 2003 has been notified as "In case of consignments requiring pre-shipment fumigation with MBr originating from countries which have phased out the use of MBr for quarantine and pre-shipment purposes, the consignment shall be released after charging the normal inspection fee. The NPPO of the country will be required to submit relevant documents to NPPO India to establish phased out country status. NPPO India would notify the list, which would be updated regularly based on the information received."

Consequent to this, NPPO, India has communicated to 194 IPPC member countries and sought their MBr phased out status for quarantine and pre-shipment purposes with document evidence. On the basis of response received from various IPPC member countries, the list of MBr phased out countries status for quarantine and pre-shipment purposes has been compiled and the same is furnished as *Annexure I*.

In view of the above, you are all directed to comply the conditions specified in the Gazette Notification issued vide S.O. 4871(E) dated 13.10.2022 to these 45 IPPC member countries with immediate effect until further orders.
