| 6. Description of content: This Resolution restricts the importation of whole potato (<i>Solanum spp.</i>) plants and parts thereof, including tubers, from countries where the following pests exist: <i>Leptinotarsa decemlineata, Agriotes lineatus, Agriotes obscurus, Agriotes sputator, Agrotis segetum, Omophlus lepturoides, Nacobbus aberrans, Globodera pallida, Colletotrichum coccodes, Geotrichum candidum, Helicobasidium brebissonii, Helicobasidium purpureum, Helminthosporium solani, Oospora pustulans, Phoma exigua var. exigua, Phoma exigua var. foveata, Pythium vexans, Potato Virus A (PVA), Potato Virus M (PVM), Potato Virus T (PVT), Tobacco Ringspot Virus (TRSV), Tobacco Rattle Virus (TRV), Potato Yellow Vein Disease (PYVD), Beet Curly Top Virus (BCTV), Tomato Spotted Wilt Virus (TSWV) and Potato Yellow Vein Virus (PYVV).</i> Importation of seeds of this species (tubers, microtubers, in-vitro plants and sexual seeds) will be permitted, subject to a risk analysis of each individual case. The purpose of this Resolution is to protect the horticultural production of potato (<i>Solanum spp.</i>) plants and parts thereof (including tubers) from quarantine pests for Venezuela which could affect such production as a result of the importation into the country of living material of this horticultural species from countries where it is found and where it is affected by these pests. |
