6.	Description of content: The Ministerial Decree "Seed and tuber registration" aims to ensure the management and the documentation of the varieties of imported and local seed. Imports of these seeds will be prohibited unless it is registered in accordance with the requirements described in the Ministerial Decree. Also, circulation of produced local seeds will not be allowed unless it is registered in accordance with the requirements described in the Ministerial Decree. The release of the consignment of seeds will not take place unless it is accompanied by a germination and purity certificate issued from a laboratory accredited to the International Seed Testing Association (ISTA) or from a government laboratory or from an accredited laboratory certified by the competent authority in the country of origin.
