**PLANT PEST AND DISEASE (IMPORT
CONTROL) REGULATIONS, 1997**

The Minister in exercise of the powers conferred on him by section 12 of the *Plant Pest and Disease (Import Control) Act* makes the following regulations:

1. These regulations may be cited as the *Plant Pest and Disease (Import Control) Regulations, 1997*.

2. (1) An application for a permit to import a restricted article shall be made in the Form A set out in the First Schedule.

(2) Subject to paragraph (3), where an application for a permit has been made under paragraph (1), and the Chief Agricultural Officer approves the application, he shall grant the permit in accordance with the provisions of the Act and regulations on such terms and conditions as he considers appropriate and in the Form B set out in the First Schedule.

(3) All permits granted under paragraph (2) shall be subject to the condition that each importation of planting material must be accompanied by a phytosanitary certificate issued by the appropriate government department or agency in the country of export.

3. (1) An importer of restricted articles shall promptly notify the Chief Agricultural Officer or

inspector of the arrival of the restricted articles at a port of entry in Barbados.

(2) Where the Chief Agricultural Officer grants permission to an importer to remove restricted articles from a port of entry for the purposes of an inspection under section 6(1)(b) or (c) of the Act, the Chief Agricultural Officer shall issue a permit to the importer in the Form C of the First Schedule.

4. (1) For the purposes of the Act and these regulations

(a) the Grantley Adams International Airport or any other airport within the meaning of the *Airports Act*;

(b) the Bridgetown Deep Water Harbour;

(c) the Bridgetown Shallow Draught Facility;

(d) Carlisle Bay;

(e) The Careenage; and

(f) any harbour not mentioned in paragraphs (b) to (e) to which the Second Schedule to the *Barbados Port Authority Act* applies,

shall be ports of entry.

5. (1) Any planting material imported for the purposes of propagation

(a) must be of the smallest propagative unit consistent with good horticultural practices; and

(b) must be soil free.

(2) Packing material as set out in Part A of the Second Schedule and approved by the Chief Agricultural Officer may be used to cover the roots of imported planting material from which soil has been removed.

(3) The packing materials specified in Part A of the Second Schedule may be imported into Barbados.

(4) The packing materials specified in Part B of the Second Schedule shall not be imported into Barbados. Second

(5) The importation of any restricted article which is prohibited or regulated by order under section 8(2) of the Act shall not be imported as packing material.

(6) For the purposes of section 9 of the Act, the Chief Agricultural Officer shall designate the areas in which and conditions under which restricted articles which are being conveyed through Barbados shall be kept.

- (c) The planting material shall be disinfected, fumigated or otherwise treated to the satisfaction of the Chief Agricultural Officer before being imported into this island.

SECOND SCHEDULE

Entry of Packing Materials

Regulations 5(3), (5)(4)

Part A

Entry of the following packing materials is permitted:

- (1) Sterilized peat or sphagnum moss
- (2) Excelsior or woods wool
- (3) Osmunda Fibre
- (4) Exfoliated vermiculite
- (5) Ground Cork
- (6) Wood shavings

Part B

Entry of packing materials incorporating the following plants, plant parts or article is prohibited

- (1) Citrus plants and plant parts
- (2) Cotton plants and plant parts and cotton products
- (3) Forest Litter
- (4) Grass plants and plant parts
- (5) Leaves and stems of plants in general
- (6) Sugar cane plants or plant parts
- (7) Soil
- (8) Sand
- (9) Coconut fibre
