Announcement no. 133, 2009 of AQSIQ on Taking Measures for Imported Plant Seedlings in Designated Ports of Entry

December 31, 2009

The living plant propagation materials including imported plant seedlings, plantlet, stock, scion, bigslip, corm and earthnut etc, (hereinafter referred to as Plant Seedlings) can carry high quarantine risks from alien harmful organism. In order to efficiently prevent alien harmful organism from invading and expanding and protect the production safety of China agricultural and forest industry, China took measures on designating ports of entry of imported plant seeds according to Law of the Peoples Republic of China on the Entry and Exit Animal and Plant Quarantine and relevant provisions, as well as following standard international practices, and also consulting with agricultural and forest department. The relevant issues are formulated as followings:

1. The ports of imported plant seedlings must possess necessary conditions including pot inspection, pest-treatment, and insulated quarantine facilities and the corresponding inspection and quarantine institutions shall be endowed with related lab inspection skill and technology ability. Based on the field assessment and evaluation by experts, the AQSIQ hereby promulgate the list of the first batch of designated qualified ports for importing plant seedlings.
2. When importing plant seedlings, importers or their agents shall legally conduct the entry inspection approval document and enter the country through designated port.
3. According to the port condition and the needs of trade, AQSIQ will adjust the list of designated entry ports for import of plant seedlings.
4. This announcement shall go into effect as of April 1, 2010.
