### **Quarantine Regulations for the Kumgangsan International Tourism Zone (Dec. 10, 2014, Decision No. 41 of the Standing Committee of the Supreme People's Assembly of the Democratic People's Republic of Korea)**

#### **Chapter 1 General provisions**

##### **Article 1 (Mission)**

This regulation strictly establishes the system and order in the quarantine service of Kumgangsan International Tourism Zone to prevent the spread of infectious diseases and pests, and to protect people's life, health, animal and plant resources.

##### **Article 2 (Types of quarantine epidemic)**

Quarantine infectious diseases include sanitary quarantine infectious diseases, animal quarantine infectious diseases, and plant quarantine pests.

##### **Article 3 (Quarantine Agency)**

In Kumgangsan International Tourism Zone (hereinafter referred to as "International Tourism Zone"), the quarantine service is conducted by the International Tourism Quarantine Service (hereinafter referred to as "Quarantine Service").

##### **Article 4 (Simplification of Procedures for Quarantine and Ensuring Rapidity)**

The quarantine office shall simplify the procedures for quarantine and to make the quarantine technologically and promptly.

#### **Chapter 2 Quarantine Targets and Quarantine Standards**

##### **Article 5 (Object of Quarantine)**

The quarantine target is as follows.

1. Personnel, processed foodstuffs, foodstuffs, foodstuffs, medicines, goods imported from communicable disease areas, warships, ships, airplanes, vehicles
2. Animals and their specimens, animal products, animal feed and additives, animal specimen management tools, veterinary medicine
3. Plants and their specimens, vegetable seeds, seeds, herbs, fruits, herbs, vegetable products such as wild plants, plant parasitic insect specimens, pesticides

##### **Article 6 (Persons and animals and animals that must not enter the Special Tourism Zone)**

The following persons and animals and animals must not enter the Special Tourism Zone.

1. People suffering from aids (including carriers), lepers, open-heart TB patients, sexually transmitted diseases, drug addicts, psychiatric patients, epidemics, and communicable diseases

2. Organisms harmful to plants and animals
3. Animal Quarantine Infectious diseases or phytosanitary animals and plant products derived from countries where pests have spread
4. Raw meat and raw meat
5. Animal carcass, soil

#### **Article 7 (Not subject to quarantine)**

The following subjects are not quarantined.

1. Persons holding an International Vaccination Certificate or a Health Certificate for International Carers
2. Person with quarantine certificate issued by another country or quarantine institution of our country, animal, animal, transportation, article
3. Fixed access and resident personnel

#### **Article 8 (Quarantine Standard)**

The quarantine standards of the International Tourism Zone shall be determined by the Central Quarantine Guidance Agency.

### **Chapter 3**

#### **Quarantine Procedures and Methods**

#### **Article 9 (Branch of Quarantine)**

Quarantine of personnel, animals and animals, transportation means, and goods in the Special Zone of International Tourism shall be carried out at designated ports, railway stations, road junctions, etc. designated by the entrance of international tourism special zones.

#### **Article 10 (Sanitation Inspection Method for Personnel)**

Personnel entering the Special Zone for International Tourism should submit a health report to the quarantine office.

The quarantine station checks the health status according to the health declaration.

#### **Article 11 (Application for Quarantine of Goods)**

If you intend to import goods into the International Tourism Zone, quarantine applications are issued with quarantine documents.

The quarantine application documents identify the product name, quantity, quality and packaging conditions, and the place of production.

#### **Article 12 (Quarantine method for goods)**

The quarantine of the goods shall be made by examining the application documents and taking samples.

The amount of sample is based on quarantine standards.

**Article 13 (Quarantine of animals and plants)**

When importing a regulated product subject to quarantine for animals and plants into an international tourism zone, quarantine applications must be submitted to the quarantine office, such as name, quantity, and place of production.

Quarantine for animals and plants shall be made by examining the application documents and conducting laboratory tests or quarantine.

**Article 14 (Quarantine Time for Quarantine of Animals and Plants)**

Quarantine for animal and plant quarantine objects shall be made upon arrival at the point of entry. However, the object of quarantine for flora and fauna placed on the ship is quarantined between the time of the sunrise and the time of its disposal.

**Article 15 (Quarantine of transportation means)**

The quarantine application for transportation means shall be made by the person in charge of transportation.

Quarantine stations should quarantine places such as the passenger cabin, crew cabin, luggage compartment, kitchen, and grocery store.

**Article 16 (Request for quarantine)**

The quarantine station may quarantine the quarantine object that can not be quarantined by itself, by asking the relevant specialized agency.

**Article 17 (Establishment of quarantine)**

The quarantine station shall inspect quarantine objects under the burden of the burdened person or his agent.

**Article 18 (Obligation to Notify Infected Patients)**

The person in charge of transportation means such as train, boat or car should notify the quarantine office as soon as they arrive at the point of entry if there is an epidemic.

**Article 19 (Guarantee of Conditions for Quarantine)**

The quarantine office may require the person receiving the quarantine to guarantee the conditions related to the quarantine.

The person receiving the quarantine shall ensure the conditions necessary for quarantine.

**Article 20 (Quarantine fee)**

The quarantine recipient must pay a fixed quarantine fee or disinfection fee.

The quarantine fee and disinfection fee shall be determined by the International Tourism Zone Guidance Agency in consultation with the State Price Agency.

**Article 21 (Treatment of the object raised in the quarantine process)**

The Quarantine Service may take the following actions:

1. Isolate the infected person or suspected infectious disease.
2. Disinfect or bury contaminated or suspected items in infectious diseases.
3. Do vaccination and treatment business.

**Article 22 (Notification and countermeasures against the risk of infectious diseases)**

The quarantine station shall notify the relevant quarantine authorities in time and take necessary measures when the risk of the occurrence or spread of the epidemic is established in the International Tourism Zone.

**Article 23 (Cooperation with Quarantine Project)**

The quarantine station shall exchange or cooperate with the central quarantine guiding agency to exchange necessary information in order to prevent the occurrence and propagation of infectious diseases in the international tourism zone.

**Chapter 4  
Sanctions and Petitions****Article 24 (Sanctions)**

In the event of a violation of these provisions, sanctions shall be given such as suspension of entry or withdrawal of goods, withdrawal of goods, withdrawal, fines, detention or confiscation.

**Article 25 (Investigation and Treatment)**

If you have any comments on quarantine, you may appeal to the Quarantine Service or the International Tourism Zone Management Committee or the International Tourism Zone Guidance Agency.

The agency that received the petition must process it within 15 days from the date of receipt.
