Title, language and number of pages of the notified document: Resolution Restricting the Importation of Whole Garlic (<i>Allium sativum</i>) Plants and Parts Thereof, Including Bulbs for Seed and Consumption, Originating in or Consigned from Countries Where the Species Is Found and Is Affected by Pests (as specified in point 6 below) (3 pages, in Spanish).
6. Description of content: This Resolution restricts the importation of whole garlic (<i>Allium sativum</i>) plants and parts thereof, including bulbs for seed and consumption, from countries where the following pests exist: <i>Botrytis porri, Penicillium corymbiferum, Penicillium cyclopium, Puccinia allii, Urocystis cepulae, Brachycerus albidentatus, Dyspessa ulula, Eumerus strigatus, Meloidogyne chitwoodi</i> and <i>Aphelenchoides fragariae</i> . Importation will only be permitted subject to a risk analysis. The purpose of this Resolution is to protect the horticultural production of garlic (<i>Allium sativum</i>) plants and parts thereof, including bulbs for seed and consumption, from quarantine pests for Venezuela which could affect such production as a result of the importation into the country of living material of this horticultural species from countries where it is found and where it is affected by these pests.
