## Notification of the presence of a harmful organism

1	General information	
1.1	Title	First finding of Cowpea mild mottle virus (CPMMV) in Germany (Bavaria)
1.2	Executive summary	In December 2022, the Netherlands detected Cowpea mild mottle virus (CPMMV) for the first time in 1112 potted <i>Hibiscus syriacus</i> , Tricolor' plants. The plants were prepared for final consumers and were inspected post entry. The plants originate in Israel and were imported in March 2022. On 7 <sup>th</sup> September 2022, 3 plants of this lot were sold to a nursery in Bavaria. The concerned 3 <i>Hibiscus</i> plants were seized and sampled in the Bavarian nursery. Symptoms were not visible on the foliage-free plants that were placed outdoors in January. The samples were tested in the official Bavarian laboratory and Cowpea mild mottle virus (CPMMV) was identified.  The 3 plants of Hibiscus syriacus 'Tricolor' were cut in small pieces and destroyed in residual waste by burning.
		The competent authority in Bavaria considers the outbreak eradicated.
