The Main State Inspection Board of Republic on Plants Quarantine Ministry of Agriculture and water economy Republic of Uzbekistan informs you that according to the Law of Republic Uzbekistan " On quarantine of plants ", clause 11, from 31.08 1995y Noll3-1 " import in the republic from foreign countries of seeds, plants, production of plants is supposed at presence: the phytosanitary certificate or the certificate which are given out by the state bodies on quarantine and protection of plants of the country of the exporter " .

In connection with the above-stated, Uzboshdavkarantin asks you to consider our offer, to assist and direct the corresponding instruction to the state post service, its divisions, branches and all post "DHL", FeDex and to other bodies of post service of your country, and also all Botanical Gardens which are being in territory of your country the instruction on those, at sending on export to Republic of Uzbekistan to address of: Tashkent s., the Botanical garden, street D.Abidova, 232 seeds, plants, production of plants, are necessary, that Botanical gardens of your country and other organizations, campaigns, firms, and other should make out and put all to post packages and in other cases the phytosanitary certificate of the international sample, according to the International standard on phytosanitary measures ISPM No 12 " Guidelines for phytosanitary certificates " .

In case at quarantine surveillance in parties of seeds, plants, production of plants will not have the phytosanitary certificate, acted in Republic of Uzbekistan to address of: the Botanical garden, to the Uzbek science-research institute of plant growing, and also other science-research institutes, other legal organization, firms and physical persons are citizens of Republic Uzbekistan import of such parties seeds, plants, production of plants on territory of Uzbekistan will be prohibition, and seeds, plants, production of plants will be eliminate and landing of the seeds, plants will be prohibition.
