SUBSIDIARY INFO - Certificates must be issued within 14 days of when the product is shipped, unless a specific deadline is listed under the import requirements for the plant or plant product. No alterations or erasures are permitted.

Quarantine requirements on importing of agriculture sprouts & plants from abroad.

- 1- Prohibited and banned species and categories are not allowed (fruitful palm, decorative palm).
- 2- Imported shipments should be free of any pests and plant disease.
- 3- Plants should be free of natural soil.
- 4- Related Health Certificate issued by relevant authority from the exporting country proving that the shipment is free from any quarantine pests which is in conformity to the International Agricultural Quarantine Legislation in Libya.
- 5- Packing should ensure that the relevant shipment is not affected or damaged, which in away is appropriate for plant shipment in order to exclude any external influence.
- 1- In case of breach of any of the mentioned conditions the supplier is committed to comply to the decision of the inspector of the Control Centre for Food and Medicine related to the imported shipment. Implement and execute shipment refusal, reexport procedure, chemical treatment, or supervised destruction by the inspectors from the mentioned centre.

Quarantine requirements on importing of agriculture seeds from abroad.

- I- All imported shipments must be completely free from any pests or any of its development stages.
- 2- Must be free of any pathogens and toxins.
- 3- Must be free of any toxic and harmful weed seeds.
- 4- Must not be genetically modified and attached with a relevant certificate.
- 5- Must be in conformity to the data sheet related to the technical specification of the type associated to the shipment.
- 6- Related Health Certificate issued by relevant authority from the exporting country proving that the shipment is free from any quarantine pests which is in conformity to the International Agricultural Quarantine Legislation in Libya. If chemically treated it must be mentioned in the certificate mentioning the kind, dose, and the date of the treatment.
- 7- In case of breach of any of the mentioned conditions the supplier is committed to comply to the decision of the inspector of the Control Centre for Food and Medicine related to the imported shipment. Implement and execute shipment refusal, reexport procedure, chemical treatment, or supervised destruction by the inspectors from the mentioned centre.

Agriculture quarantine requirements on importing of timber from abroad.

- 1- Imported timber must be free of any pests or disease, or any harmful organisms through any phase of development does not show any trace of such effect.
- 2- Imported timber must be free of any bark (peel).
 - 3- Related Agriculture Health Certificate issued by relevant authority from the exporting country proving its testing and that the shipment is free from any pests or any plant disease or any part of bark (peel). If chemically treated it must be mentioned in the certificate mentioning the kind, dose, and the date of the treatment.
 - 4- In case of breach of any of the mentioned conditions the supplier is committed to comply to the decision of the inspector of the Control Centre for Food and Medicine related to the imported shipment. Implement and execute shipment refusal, reexport procedure, chemical treatment, or supervised destruction by the inspectors from the mentioned centre.

Quarantine requirements on importing of feed grains and raw materials used for their production.

- 1- All imported shipments must be completely free from any pests or any of its development stages (insects, spiders, ...etc.).
- 2- Must be free of any toxic and harmful fungi and its toxins, the contamination of Ergot fungi if found shall not exceed 0.01%.
- 3- Must be free of any toxic and harmful weed seeds.
- 4- Related Health Certificate issued by relevant authority from the exporting country proving that the shipment is free from any quarantine pests which is in conformity to the International Agricultural Quarantine Legislation in Libya. If fumigated it must be mentioned in the certificate declaring the kind, dose, and the date of fumigation.
- 5- Shipments must comply with the standards and specification of the National Center of Standardization and Metrology related to the consignment.
- 6- In case of breach of any of the mentioned conditions the supplier is committed to comply to the decision of the inspector of the Control Centre for Food and Medicine related to the imported shipment. Implement and execute shipment refusal, reexport procedure, chemical treatment, or supervised destruction by the inspectors from the mentioned centre.
