Notification of the presence of a harmful organism - closing note

1	General information	
1.1	Title	Eradication of an outbreak of Tomato brown rugose fruit virus (ToBRFV) in Germany (Baden-Wuerttemberg)
1.2	Executive summary	In June 2022, the plant protection service of Baden-Württemberg carried out an inspection due to registration according to Article 65 of Regulation (EU) 2016/2031 at an amateur gardener offering tomato seeds in his online store. Seed samples of all 92 varieties were taken and tested in the official laboratory of Baden-Wuerttemberg as 13 mixed samples. 4 of the mixed samples were tested positive. For 4 mixed samples, the result was uncertain and retesting was necessary. All mixed samples were retested in the national reference laboratory with the same result. Distribution of all positive and uncertain seed lots has been forbidden and retesting of the 49 varieties has been performed by the national reference laboratory in September 2022. In total 11 varieties were tested positive. The infested seed lots have been destroyed. Seeds of the following varieties were found to be infested: 'Persuasion', 'Cherokee purple', 'Rheinlands Rhum', 'Helsing Junction', 'Liguria', 'Grappolo', 'Katinka', 'Black Zebra Cherry', 'Fiaschetto', 'Money Maker' and 'Datlo'.
		Trace-back investigations are completed. The online trader has informed all end consumers who had purchased seeds from the infested seed lots and requested the return of any remaining seeds. Most of the end consumers had already sown the seeds in spring 2022 and there were no plants left. The returned seeds were destroyed. The seeds of the affected lots still available at the online trader were also destroyed. In 2022, all mother plants of the online trader were tested, no infestation with ToBRFV could be detected (These mother plants are not related to the mother plants from which the seed was harvested in 2021). The outbreak is considered to be eradicated.
